Data Processing The water-level elevations presented must be considered approximate because of the potential error in the GPS-based elevation of the land surface at **Data Limitations** the well site which is believed to be on the order of +/- 1.75 ft. according to work performed by the Center for Nuclear Waste Regulatory Analyses. The potential error in the GPS-based elevations does not affect the depth to water nor the absolute change in water levels over time that may be calculated using the elevation datum for land surface. The potential error may, however, result in limitations in the use of these data for the calculation of hydraulic gradients between wells with the error induced in such calculations being inversely proportional to the distance between the two wells being used to perform the calculation.
